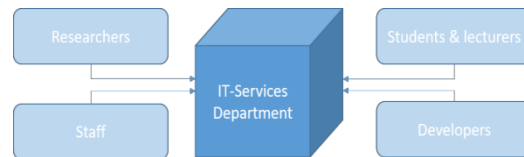


Fig.1. The main structure of the IT services users in any institution.

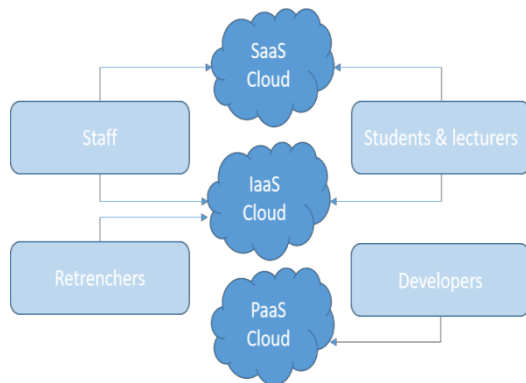


Fig.2. The main structure of the IT services users in any institution using Cloud Computing.

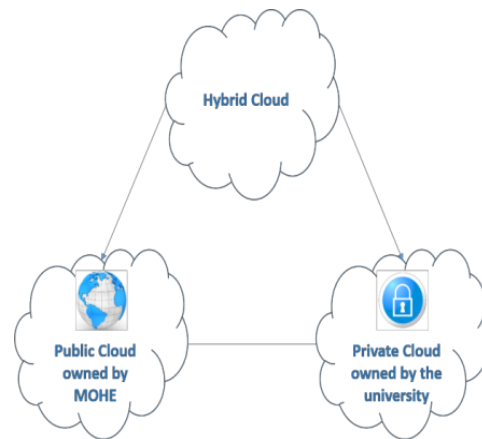


Fig.3.The proposed hybrid cloudmodel.
